Notice Concerning Appointment of Accounting Auditor

robot home Inc. (the “Company”) hereby announces that, at a meeting of the Audit and Supervisory Committee held on February 20, 2026, the Company resolved to change the certified public accountant, etc. who perform the audit certification set forth in Article 193-2, Paragraphs 1 and 2 of the Financial Instruments and Exchange Act. In addition, at a meeting of the Board of Directors held on the same day, the Company resolved to submit the proposal entitled “Appointment of Accounting Auditor” to the 20th Annual General Meeting of Shareholders scheduled to be held on March 25, 2026. The details are as described below.

1. Date of appointment

March 25, 2026 (the scheduled date of the 20th Annual General Meeting of Shareholders)

2. Overview of incoming certified public accountant, etc.

3. Reason for nominating the auditor described in item 2 as a candidate for certified public accountant, etc.

As disclosed in the Company’s announcement dated June 20, 2025, entitled “Notice Concerning Change of Accounting Auditor and Appointment of Temporary Accounting Auditor,” the Audit and Supervisory Committee resolved at its meeting held on the same date to appoint UHY Tokyo & Co. as the temporary accounting auditor, and the Company has continued with this arrangement to date. Although UHY Tokyo & Co. will complete its term as temporary accounting auditor upon the conclusion of the 20th Annual General Meeting of Shareholders scheduled to be held on March 25, 2026, the Company has determined, based on its performance of duties as temporary accounting auditor, that the same audit corporation remains appropriate to serve as the Company’s accounting auditor. This determination was made in light of factors such as the Company’s business scale, the suitability of the audit services to the Company’s business content, the reasonableness of audit fees, and the auditor’s possession of the expertise, independence, and quality control system required of an accounting auditor. Accordingly, the Company proposes the appointment of the same audit corporation as its accounting auditor.
