## Notice of Financial Forecasts Revision

Japan Petroleum Exploration Co., Ltd. (JAPEX) hereby revised its consolidated financial forecasts for the fiscal year ending March 31, 2026, which was disclosed on August 7, 2025, based on our recent business trends and performance. Dividend forecast remains unchanged regardless of this matter.

#### 2. Reasons for revision

Compared with the previous forecast (August 7, 2025), net sales and profits are expected to increase mainly due to a rise in crude oil and natural gas sales prices.

#### 3. Dividend forecast

Our basic policy for profit distribution is to pay dividends in line with business results for each fiscal year, with a target consolidated dividend payout ratio of 30% basically.

JAPEX maintains its initial forecast of interim dividend (20 yen per share) and year-end dividend (20 yen per share) for the fiscal year ending March 31, 2026, but will decide year-end dividend taking into consideration a full-year business results and other factors.
