1. Qualitative Information on the Financial Results for the Period under Review

(1) Overview of Operating Results

During the first quarter, the UK Ministry of Defence released a policy paper titled the "Strategic Defence Review 2025" in June, which positioned space as "the forefront of strategic competition" and outlined a policy to strengthen defense-related use of space and promote collaboration with the space industry. In July, Japan's Ministry of Defense and the Self-Defense Forces formulated the Space Domain Defense Guidelines, reaffirming the need to enhance Space Domain Awareness (SDA) capabilities and to support investment in related areas by commercial entities. These developments reflect a continued trend among government agencies worldwide to reinforce space defense.

Recently, particularly in defense-related projects, the trend of allocating government budgets for space and commercial operators has been accelerating. The Group is leveraging its competitive advantages—outstanding technology, global outreach and market generation capability—to further expand its business.

During the first quarter, the Group entered into multiple contracts across various locations with civil government agencies, defense-related organizations, and commercial entities. In addition, we made progress in technological initiatives aimed at mid-to long-term growth, including the acquisition of a new patent that could serve as a technical foundation for Active Debris Removal (ADR).

As a result, bookings for the first quarter totaled ¥1,443 million. As of the date of this document, major new project awards and progress on existing projects are as follows:

(Civil/Commercial projects)

- May 2025: Completed delivery on the contract for COSMIC Phase 2.
- June 2025: Completed Critical Design Review (CDR) for ELSA-M.
- July 2025: Acquired a new patent related to multiple debris removal and controlled reentry.
- August 2025: Secured a commercial contract for the second-generation docking plate.
- September 2025: Concluded contract for REFLEX-J (ex-K Program).

(Defense-related projects)

- June 2025: Contracted a new defense-related project (details undisclosed).
- July 2025: Awarded a new defense research project from the U.S. Air Force Research Laboratory concerning autonomous rendezvous, proximity operations, and docking.

Furthermore, in July 2025, the UK launched a public solicitation for the next phase of COSMIC following the completion of Phase 2 in May 2025. The Group is actively pursuing the tender to secure the contract.

Amid growing global momentum for policies that drive both government and commercial demand for space-related spending and on-orbit servicing, the Group is strengthening business alliance and technological development to expand opportunities in on-orbit servicing. In May 2025, we initiated joint development of a satellite refueling port connection system with Honda R&D Co., Ltd., with plans for technology demonstration under REFLEX-J. This initiative anticipates increased demand for refueling services. Furthermore, in September 2025, we signed a contract with NewSpace India Limited to use the Polar Satellite Launch Vehicle (PSLV) for the launch of ISSA-J1 into polar orbit. We are making steady progress on our existing projects toward milestone achievement.

On the regulatory front, in June, the European Commission—the executive body of the European Union—announced a draft of the EU Space Act, signaling a policy direction toward harmonizing rules for space activities across the EU. This development is contributing to the creation of an environment that facilitates cross-border business expansion.

As a result, for the three months ended July 31, 2025, revenue was \$1,250,333 thousand (up 422.3% year-on-year), operating loss was \$2,376,063 thousand (operating loss of \$7,597,659 thousand in the three months ended July 31, 2024), loss before income tax was \$1,210,231 thousand (loss before income tax of \$8,579,659 thousand in the three months ended July 31, 2024) mainly due to foreign exchange gain (finance income) of \$1,321,341 thousand and interest expenses (finance costs) of \$165,109 thousand, and loss attributable to owners of the parent was \$1,211,251 thousand (loss attributable to owners of the parent of \$8,579,996 thousand in the three months ended July 31, 2024).

For reference, project income* for the three months ended July 31, 2025 was \(\frac{4}{2}\),368,790 thousand (up 103.1% compared to the three months ended July 31, 2024), of which, government subsidy income was \(\frac{4}{1}\),118,457 thousand.

(*) We present above project income, which includes revenue from customers and government subsidy income only related to grants for which use is tied to specific projects. We believe project income provides investors with additional information in relation to the sources of income derived from our project-related activities, as we pursue a wide range of project activities regardless of the funding scheme. Management monitors project income as the primary indicator of income of project-related activities. Project income is not a financial measure prescribed by IFRS but is a supplemental financial measure that we believe is useful for investors to assess income derived from projects and their funding sources. However, non-IFRS measures have a number of important limitations and should not be viewed as a substitute for financial information prepared in accordance with IFRS. Due to the limitations inherent in non-IFRS measures, investors should not solely rely on non-IFRS measures in assessing our performance and financial condition.

(2) Overview of Financial Position

Assets

Total assets were \(\frac{\pmathbf{4}}{4}\),021,655 thousand, an increase of \(\frac{\pmathbf{7}}{7}\),396,364 thousand from the end of the fiscal year ended April 30, 2025. This was mainly due to an increase of \(\frac{\pmathbf{4}}{4}\),510,019 thousand in cash and cash equivalents resulting from proceeds from issuance of shares and an increase of \(\frac{\pmathbf{1}}{1}\),877,918 thousand in property, plant and equipment.

Liabilities

Total liabilities were ¥26,435,764 thousand, a decrease of ¥1,063,171 thousand from the end of the fiscal year ended April 30, 2025. This was mainly due to a decrease of ¥688,301 thousand in deferred income, a decrease of ¥418,523 thousand in provisions, a decrease of ¥505,237 thousand in contract liabilities and a decrease of ¥124,990 thousand in borrowings, while trade and other payables increased by ¥538,951 thousand.

Equity

Total equity was $\frac{14,585,890}{4,585,890}$ thousand, an increase of $\frac{10,621,818}{4,59,535}$ thousand from the end of the fiscal year ended April 30, 2025. This was mainly due to an increase of $\frac{10,621,818}{4,59,535}$ thousand in share capital and capital surplus, as a result of the issuance of new shares, while retained earnings decreased by $\frac{12,211,251}{4,59,535}$ thousand as a result of the loss for the period

As a result, the ratio of equity attributable to owners of parent to total assets was 35.6%.

Cash flow recorded through the three months ended July 31, 2025 and main factors are as follows:

Cash flow from operating activities

Cash flow from operating activities decreased our cash by 44,319,858 thousand (a decrease of 6,967,572 thousand in the three months ended July 31, 2024).

Cash flow from investing activities

Cash flow from investing activities decreased our cash by ¥1,886,399 thousand (a decrease of ¥171,101 thousand in the three months ended July 31, 2024). This was mainly due to purchase of intangible assets of ¥5,034 thousand.

Cash flow from financing activities

Cash flow from financing activities increased our cash by \$10,438,926 thousand (an increase of \$20,465,428 thousand in the three months ended July 31, 2024). This was mainly due to proceeds from issuance of shares of \$10,621,818 thousand.

(4) Special note regarding forward-looking statements

The Group continues to focus on creating and expanding the on-orbit servicing (OOS) market as the global market leader with a dominant competitive advantage in RPO technologies. Our long-term vision is to realize "secure and sustainable development of space for the benefit of future generations."

The long-term management policy to achieve this vision is as follows:

In addition to the already materialized civil demand, the Group aims to capture defense-related demand that emerged earlier than expected in the fiscal year ended April 2025, positioning it as a new short- to mid-term growth driver. Over the longer term, the Group will promote the launch of life extension services (LEX) for commercial operators. In this way, the Group intends to respond to the growing demand for OOS from government, defense agencies, and commercial sectors, driven by the expansion of the space economy, through a broad range of service offerings.

The Group also aims to achieve positive gross profit, operating profit, and free cash flow as early as possible. To reach this goal, the Group will focus on:

- (i) Increasing project income by accumulating backlog and shortening average project duration,
- (ii) Improving gross margin by increasing the fully-funded project ratio, and
- (iii) Ensuring profitability by controlling the increase rate of SG&A expenses through strict cost management.

As a long-term financial target, the Group aims for a gross profit margin in the mid-30% range and an operating profit margin in the mid-20% range.

The consolidated financial forecast for the fiscal year ending April 2026 is as follows. At the beginning of the fiscal year, due to the high uncertainty regarding the progress of contracted and selected projects, disclosure will be made using a range format to provide more useful and reasonable information to investors. The forecast figures consist only of contracted and awarded projects, and upward revisions will be made as new projects are awarded.

The backlog, which is the sum of contracted backlog and confirmed but uncontracted backlog, was \(\frac{\pmathback}{43,717}\) million as of the end of July 2025. With improving the fully-funded projects ratio and shortening the average project duration, project income—defined as the sum of revenue and government subsidy income—is expected to reach \(\frac{\pmathback}{11,000}\) million to \(\frac{\pmathback}{13,000}\) million (up 80.7% to 113.5% year-on-year). The upper bound reflects the scenario where contracted and selected projects progress without delay, while the lower bound accounts for potential impacts from project schedule delays and other external factors based on the fiscal year ended April 2025. At this point, uncontracted and unawarded new projects are not included even in the upper bound forecast. The breakdown of project income includes revenue of \(\frac{\pmathback}{5,000}\) million to \(\frac{\pmathback}{6,000}\) million (up 103.5% to 144.2% year-on-year) and government subsidy income of \(\frac{\pmathback}{6,000}\) million to \(\frac{\pmathback}{7,000}\) million (up 65.2% to 92.8% year-on-year). A full-year positive gross profit is targeted, driven by increased revenue and a higher fully-funded project ratio.

R&D expenses mainly consist of pre-contract development costs and development costs for subsidy projects. Among these, pre-contract development costs are expected to decline significantly year-on-year. Although development costs for subsidy projects will increase with project progress, the majority will be covered by government subsidy income, resulting in a flat year-on-year impact on operating profit.

SG&A expenses, excluding R&D expenses, are expected to remain flat or slightly decrease year-on-year due to strict cost management.

As a result, operating loss is projected to be between \$10,300 million and \$9,300 million (improvement of \$48,455 million to \$9,455 million year-on-year), and net loss is projected to be between \$10,700 million and \$9,700 million (improvement of \$10,851 million to \$11,851 million year-on-year).

2. Segment Information

(1). Overview of reportable segment

The Group undertakes research and development in technologies regarding on-orbit services such as debris removal and demonstrations in outer space.

These on-orbit services developed by the Group have common underlying technologies, though there are different types depending on the orbits on which target debris or satellites exist, and service contents provided with targeting them. Accordingly, the Group's senior management decision-making body reviews operating results to determine the allocation of management resources and evaluate the business performance, targeting the entire on-orbit servicing business. Therefore, the Group considers the business segment as a single segment of the on-orbit servicing business and single reportable segment, and omitted information by reportable segment.

(1). Conclusion of a significant contract

Astroscale Japan Inc., our Japanese subsidiary, signed a commissioned research contract with the Japan Science and Technology Agency for refueling technology in space with a cooperative satellite on September 1, 2025.

Total Budget: ¥10.8 billion (excluding tax)

Project Duration: In principle, within 5 years (60 months) from the start of R&D

Contract Amount: ¥0.59 billion (excluding tax)

Contract Period: Up to the end of March 2026

The contract period will be extended by one year at a time through amendment contracts on April 1 each year, and the total contract amount is expected to be the above total budget of ¥10.8 billion (excluding tax).

Project income from this initial contract is expected to be recognized over the contract period (up to the end of March 2026).
