Notice on Change in Specified Subsidiary

On July 18, 2025, Daito Trust Construction Co., Ltd. (hereinafter, “the Company”) resolved to invest in KME PROP REAL ESTATE L.L.C (hereinafter, “KME”) jointly with KME INVESTMENT & MANAGEMENT L.L.C, a wholly-owned subsidiary of Kasumigaseki Capital Co., Ltd. (located in Chiyoda-ku, Tokyo; President & CEO: Koshiro Komoto), for the purpose of developing the Real Estate Development Business in Dubai. Pursuant to the resolution, the Company invested in KME in August 2025. As a result, the capital of KME exceeded 10% of the Company’s capital and KME has become a specified subsidiary of the Company, which was required to disclose.
