- 2. Role of listed company in the corporate group of the parent company or other entity and relationship with other listed companies and parent company or other entity
- (1) Kyudenko is an equity-method affiliate of the Kyushu Electric Power Group, which is operated by Kyushu Electric Power Co., Inc.
- (2) Kyudenko performs construction work involving power transmission equipment and other facilities operated by the Kyushu Electric Power Group. Contracts from the Kyushu Electric Power Group account for 12.5% of all work completed by Kyudenko during the current fiscal year. The terms under which construction work is ordered are determined through price negotiations in
  - line with standard transaction terms based on a consideration of market pricing and other relevant factors.
- (3) Personnel relationships include three employees who have been seconded from the Kyushu Electric Power to Kyudenko's digital transformation department and other departments and three employees who have been seconded from the Kyushu Electric Power Group to Kyudenko's transmission construction department and other departments.
- (4) Although Kyudenko is engaged in construction transactions as well as personnel and capital relationships with the Kyushu Electric Power Group as described above, Kyudenko believes it has established a certain degree of independence since its area of business (facilities construction) differs from that of the Kyushu Electric Power Group, and because it conducts its business activities in accordance with its own management policies and management decision-making.
