# **Notice Regarding Transfer of Shares in Subsidiary**

MEGMILK SNOW BRAND Co., Ltd. (Representative Director and President: Masatoshi Sato, the "Company") hereby announces that Snow Brand Seed Co., Ltd. (Representative Director and President: Takuya Maruta, "Snow Brand Seed"), the Company's subsidiary, decided to transfer all the shares of the Company's consolidated subsidiary Royal Farm, Ltd. (Representative Director and President: Yasushi Kosaka, "Royal Farm") to Jinnai Farm21 Co., Ltd. (Representative Director: Masaki Takayama) (the "Share Transfer"), concluded a share transfer agreement on September 8, 2025 (the "Agreement"), and completed the transfer of all shares on October 10, 2025. In conjunction with the Share Transfer, Royal Farm and its subsidiaries RF Aomori Farm Co., Ltd. and RF Penkel Farm Co., Ltd. (Representative Director and President for both: Yasushi Kosaka) will be excluded from the Company's scope of consolidation.

Since the establishment of Royal Farm in 2001, the Company has worked with Snow Brand Seed to develop its business. However, it has now been determined that the best way for Royal Farm to achieve further growth and pursue business development is to transfer Snow Brand Seed's shares in Royal Farm to Jinnai Farm21 Co., Ltd., and the Agreement has been concluded accordingly.

The Megmilk Snow Brand Group will continue working to build a stronger Group value chain by leveraging the strengths of each Group company.
