### Notice Regarding Belle Neige Direct Co., Ltd. Becoming a Wholly Owned Subsidiary

(Representative Director and President: Masatoshi Sato; the "Company") hereby announces that the Company decided to acquire all the shares of its subsidiary Belle Neige Direct Co., Ltd. (President and Representative Director: Tomohide Yoshikawa) owned by SENSHUKAI Co, Ltd. (Representative Director and President: Satoshi Suzuki), concluded a share transfer agreement on December 22, 2025, and completed the acquisition of all shares on December 24, 2025. The details are as follows.

In the direction for business portfolio transformation under the new management plan Next Design 2030, the functional food products business is positioned as an "acceleration of growth" category, which will drive the Group's growth. Belle Neige Direct Co., Ltd. is an important subsidiary responsible for fulfillment and other functions in the Company's functional food products business, and the Company decided to make it a wholly owned subsidiary to expand and grow the functional food products business and speed up execution through further utilization of Belle Neige Direct's management resources.
