# Notice Regarding Changes to the Shareholder Benefit Program

We hereby announce that we have resolved today to revise our shareholder benefit program effective as of the end-of-July record date, as outlined below.

#### 1. Reason for the Change

We have designed our shareholder benefit program with the intention of deepening shareholders' understanding and affinity for the Group's businesses. In addition, by encouraging customers who regularly use the Group's facilities and services to become shareholders, the Company aims to build stronger engagement and support from both its shareholders and customers.

Accordingly, we have decided to revise the shareholder benefit program to further enhance the attractiveness of its stock and to encourage long-term shareholding.

## 2. Details of the Change

We hereby announce changes to a portion of our shareholder benefit program, as outlined below..

## [Theme Park]

- The admission discount ticket for Rindoh-ko Family Farm will be changed to a free admission ticket.
- A new 10% discount coupon for use at "Mekke! Marche" located in Rindoh-ko Family Farm will be added to
  the benefits.
