Notice Regarding Receipt of Dividends from a Consolidated Subsidiary

GODO SHUSEI CO., LTD., a consolidated subsidiary of the Company, resolved at its Board of Directors meeting held on February 26, 2026, to submit a proposal for the distribution of surplus to the shareholders' meeting scheduled for March 19, 2026.
