Notice Concerning Submission of Amendment Report Pertaining to Securities Report from Prior Fiscal Years and Reamendment to Financial Results for Prior Fiscal Years

On August 25, 2025, KEY COFFEE INC (the "Company") hereby announces that the Company submitted an amendment report pertaining to a securities report to the Director-General of the Kanto Local Finance Bureau and also made an amendment to its financial statements as described below.

We sincerely apologize for the significant inconvenience and concern caused to shareholders, investors, and other stakeholders.

1. Background and reason for amendments

As stated in "Notice Concerning Disclosure of Financial Results for the Three Months Ended June 30, 2025 Exceeding 45 Days after 1st Quarter End" dated August 8, 2025, the Company has decided to postpone the disclosure of its financial results for the three months ended June 30, 2025, due to the impact of certain issues on the Company's financial-related data that arose in conjunction with the introduction of a new core system by the Company in January 2025.

Furthermore, it was found that the said issues had impact on the accounting treatment for prior fiscal years, and after consultation with the audit firm, we have determined that it is necessary to make amendments to our consolidated financial statements and other information in the already submitted securities report. Accordingly, we have submitted them to the Director-General of the Kanto Local Finance Bureau today, and determined to amend the Financial Results again.

The financial results for the first three months ended June 30, 2025, are not impacted as a result of applying the effects of the amendment retroactively to prior fiscal years.
