December 2025 Operating Results

ASKUL Corporation releases non-consolidated monthly operating results for December of the fiscal year ending May 20, 2026.

Net sales

Non-consolidated net sales for December (from November 21, 2025 to December 20, 2025) decreased by 75.0% year-on-year to 8,856 million yen. Non-consolidated net sales of the mainstay ASKUL Business decreased by 72.7 % year-on-year to 8,843 million yen.

Non-consolidated net sales of LOHACO Business decreased by 99.5 % year-on-year to 13 million yen. LOHACO is scheduled to resume in January 2026.

Notes:

1. The total of non-consolidated net sales includes net sales of the Logistics Business.
2. For monthly operating results, accounts are settled as of the 20th of each month on a provisional basis.

■Progress of the Full Restoration Phase of ASKUL Business

From December 25, ASKUL has resumed product shipments using its logistics systems at both the ASKUL Sendai DC and the ASKUL Fukuoka DC. As a result, the number of products available for single-item orders has expanded from approximately 16,000 items to approximately 25,000 items.

At this stage, shipment bases remain limited, and lead times are approximately 1 to 7 days. While placing the highest priority on safe operations, ASKUL will continue to expand shipment centers sequentially and proceed with full restoration so that the Company can deliver the same number of products with the same lead times as before.
