## Notice regarding the Dissolution and Liquidation of a Consolidated Subsidiary

ARIAKE JAPAN Co., Ltd. (the “Company”) hereby announces that at a meeting of the Board of Directors held today, the Company decided to commence dissolution and liquidation procedures for Rizhao Ariake Foodstuff Co., Ltd. (“Rizhao Ariake”), a consolidated subsidiary.

### 1. Reasons for Dissolution

In response to a request for future removal due to land readjustment in the Qingdao City Industrial Park where Qingdao Ariake Foodstuff Co., Ltd. (“Qingdao Ariake”), a subsidiary of the Company, is located and in order to increase production to meet increasing demand in China in the future, the Company established a new company, “Rizhao Ariake,” as a candidate site for a new factory, in Rizhao City, China, on November 18, 2021,. Subsequently, despite some delays in progress due to the impact of COVID-19 and related external factors, we continued preparations for factory construction. However, in light of the fact that Qingdao City, which had originally planned to perform land readjustment, has withdrawn its request for future removal, and that the production capacity required to achieve the targets indicated the Medium-term Business Plan can now be accommodated through the expansion of facilities within the Qingdao Ariake factory, there is no longer a reasonable rationale for constructing a factory in Rizhao City. Therefore, the Company has decided to dissolve and liquidate Rizhao Ariake, which was established in Rizhao City. Separately from the Medium-term Business Plan, regarding the expansion of production capacity with an eye on the long-term growth of the Chinese market in the future, the Company expects to receive land brokerage for a new factory construction site within Shandong Province, where the company’s existing factory is located. The Company will maintain the investment plan at its current scale and continue its initiatives.
