#### 1. Overview of Operating Results, etc.

#### (1) Overview of Operating Results for the Period under Review

During the nine-month period under review, the Japanese economy is expected to continue to recover gradually driven mainly by improving employment and income conditions and rising inbound demand, despite economic downside risks including ongoing escalating tensions in the Middle East and Europe as well as the uncertainty regarding the policy direction of the new U.S. administration. In the space industry, the government is offering continuous support to position it as a growth sector in the Japanese economy, as demonstrated by the fact that the Space Strategy Fund, which is a long-term and large-scale support program of \$\frac{1}{2}\$1 trillion over 10 years, was established at the Japan Aerospace Exploration Agency (JAXA). Grant decisions under Phase 1, which started in fiscal 2024, have been made sequentially, and an outline for the subsequent Phase 2 has also been announced.

Under these circumstances, aiming "to create a new infrastructure that enables the next generation to understand our Earth and achieve a resilient future," the Group operates a satellite constellation through the development, manufacturing, and launch of its proprietary SAR satellites, StriX, which continuously observe the Earth, along with their associated systems. In addition, we are working to continuously sell the data acquired from these satellites, as well as to expand our solution offerings and develop new satellite data markets, primarily targeting socially critical areas such as natural disasters, security, and environmental risks.

#### Status of key management indicators

The Group has defined the following as key management indicators:

#### • Total revenue (net sales and subsidy income), order backlog

Total revenue amounted to ¥1,950,687 thousand (up 21.3% year-on-year). This was mainly due to steady progress in the delivery of the "Fiscal 2024 Demonstration for Expanding the Use of Small SAR Satellite Constellations" and the "Fiscal 2025 Demonstration for Expanding the Use of Small SAR Satellite Constellations" promoted by the Cabinet Office's Space Development Strategy Promotion Office, and the space demonstration of small SAR satellites suitable for security purposes promoted by the Ministry of Defense. The recording of subsidy income from Small/Startup Business Innovation Research by the Ministry of Economy, Trade and Industry ("METI SBIR") and the Space Strategy Fund's "accelerating commercial satellite constellation deployment" initiative (the "Fund") also contributed. In terms of the solutions business, the provision of existing services as well as joint solution development projects with clients, continue to progress smoothly.

#### • Number of satellites in operation

Since our founding, we have launched seven StriX satellites as part of our initiative to operate more than 30 satellites from 2028 onward. However, the first three satellites have already completed their commercial operations. As of the end of the third quarter under review, we are operating four satellites in orbit.

Regarding satellite operations and launches, we successfully launched our seventh small SAR satellite on October 15, 2025. Additionally, we entered into launch contracts for ten satellites with Rocket Lab (headquartered in California, USA) and for three satellites with SpaceX (headquartered in California, USA), respectively, and we have currently secured contracts for the future launch of 23 satellites in total.

#### Status of cost of sales and selling, general and administrative expenses

Cost of sales amounted to ¥1,882,908 thousand (up 39.6% year-on-year). This was mainly due to increased depreciation and amortization for satellites No. 4 through 6, as well as direct costs related to the Cabinet Office's demonstration project and space demonstrations of SAR satellites.

Selling, general and administrative expenses totaled \(\frac{1}{2}\),949,910 thousand (up 32.4\% year-on-year). This

was primarily driven by increased share-based compensation expenses, higher personnel costs resulting from increased headcount, and higher outsourcing expenses due to the expansion of our sales structure.

#### Financial condition

On the financial side, we raised \(\frac{\pmathbf{\frac{4}}}{1,418,846}\) thousand through a third-party allotment of shares (related to over-allotment), with a payment date of January 17, 2025, in connection with the issuance of shares through public offering accompanying the listing of our common shares on the Tokyo Stock Exchange Growth Market. In addition, we newly established a syndicated loan (committed-term loan) of \(\frac{\pmathbf{\frac{4}}}{8,100,000}\) thousand, arranged by Mizuho Bank and co-arranged by Shizuoka Bank. Furthermore, following the resolution on July 28, 2025 to issue stock acquisition rights to be allotted to Nomura Securities Co., Ltd., we raised \(\frac{\pmathbf{\frac{5}}}{5,440,171}\) thousand by the end of the third quarter under review.

#### Other

In March 2025, we established a subsidiary in the United States as our business hub for North America and Latin America, the world's largest space-related market. With this new subsidiary, in addition to our existing operations in Japan and Asia, we will further accelerate the Group's growth by swiftly developing business tailored to local needs in the North American and Latin American regions.

As a result, net sales for the nine months ended September 30, 2025 was \$1,672,388 thousand (up 4.0% year-on-year), operating loss was \$3,160,430 thousand (loss of \$1,969,016 thousand in the corresponding period of the previous fiscal year), ordinary loss was \$3,418,671 thousand (loss of \$2,190,874 thousand in the corresponding period of the previous fiscal year), and net loss attributable to owners of parent was \$3,413,102 thousand (loss of \$2,189,251 thousand in the corresponding period of the previous fiscal year).

Our Group operates only one business segment, or the satellite data business. Therefore, our business results by segment are omitted.

## (2) Overview of Financial Position for the Period under Review (Assets)

The total assets as of September 30, 2025 amounted to \$32,708,202 thousand, increasing by \$4,512,866 thousand from the end of the previous fiscal year. This was primarily due to a decrease of \$863,276 thousand in accounts receivable-trade and contract assets, despite a decrease of \$1,794,092 thousand in cash and deposits as a result of the purchase of Small SAR Satellite components and prepayment of Small SAR Satellite launch costs and an increase of \$7,613,458 thousand in construction in progress.

#### (Liabilities)

The total liabilities as of September 30, 2025 amounted to \(\frac{\pma}{8}\),778,697 thousand, increasing by \(\frac{\pma}{4}\)456,301 thousand from the end of the previous fiscal year. This was primarily due to increases of \(\frac{\pma}{9}\)90,000 thousand in short-term borrowings, \(\frac{\pma}{3}\)365,000 thousand in the current portion of long-term borrowings, and \(\frac{\pma}{5}\),000 thousand in long-term borrowings, mainly owing to borrowings and repayment of loans.

#### (Net assets)

The total net assets as of September 30, 2025 amounted to ¥23,929,505 thousand, increasing by ¥4,056,564 thousand from the end of the previous fiscal year. This was primarily due to an increase of ¥3,419,629 thousand each in common stock and capital surplus resulting from the issuance of new shares through a third-party allotment and the exercise of stock acquisition rights in connection with selling due to an over-allotment in January 2025, despite the recording of net loss attributable to owners of parent of ¥3,413,102 thousand.

#### (3) Explanation of Consolidated Financial Results Forecast and Other Forward-looking Information

There is no change to the full-year consolidated financial results forecast announced.

Financial results forecasts are based on information currently available to us and certain assumptions we consider reasonable and are not intended to promise that we will achieve them. Actual business results may differ significantly due to various factors.

#### (4) Material Events Related to Going Concern Assumption

The Group posted operating losses for seven consecutive fiscal years until the previous fiscal year, and we recognize that there are events or conditions which indicate there could be substantial doubt regarding the going concern assumption.

The main reason is that the manufacturing and launching of satellites involves a major prior investment, and it takes time to recover the investment.

To eliminate these events and conditions, we plan to increase at an early stage the number of satellites, which will drive the increase in profits in the satellite data business, the Group's main business, promote the review of strategies and the expansion of the business, and increase net sales by expanding market share, while also securing stable profitability and striving to improve our corporate value.

At the end of the third quarter under review, we had cash and deposits of \$12,445,769 thousand, and as a result of considering our cash-flow situation over the next 12 months from the end of the third quarter under review, we see no significant concern about the cash-flow situation as we have operating funds for the time being.

Consequently, we determine that there are no significant uncertainties over the going concern assumption.

We listed our stock on the Tokyo Stock Exchange Growth Market on December 19, 2024. In connection with this listing, we issued new shares through public offering (by way of over-allotment), with a payment date of January 17, 2025, which resulted in an increase of ¥709,423 thousand each in common stock and capital surplus.

In addition, the exercise of stock acquisition rights resulted in an increase of \(\frac{\pma}{2}\),710,206 thousand each in common stock and capital surplus during the nine months ended September 30, 2025.

As a result, as of September 30, 2025, common stock stood at \\pm\11,099,282 thousand and capital surplus amounted to \\pm\18,762,848 thousand.
