**Notice of Revision to Disclosure of Monthly Sales Report (Preliminary)**

MarketEnterprise Co., Ltd. announces that, effective with the July 2026 monthly sales results, it will revise the content of the year-on-year comparison information disclosed in its Monthly Sales Report (Preliminary), as described below.

1. Revision to disclosure items

2. Reason for revision

Since July 2024, MarketEnterprise has disclosed its monthly consolidated net sales on a preliminary basis, together with year-on-year comparisons. However, during the previous fiscal year (the fiscal year ended June 30, 2026), the gross profit margin of the mobile & telecommunications business, one of the company's two principal business segments (the second-hand online business and the mobile & telecommunications business), deteriorated. As a result, changes in monthly consolidated net sales compared with the corresponding month of the previous year did not necessarily reflect trends in gross profit or subsequent levels of earnings. As stated in the Summary of Results of Operations for the Fiscal Year Ended June 30, 2026, released today, MarketEnterprise positions the current fiscal year (the fiscal year ending June 30, 2027) as a transitional period for the mobile & telecommunications business and anticipates a planned decline in net sales as part of its business model transformation. Accordingly, as monthly disclosures based on consolidated net sales would no longer provide a meaningful comparison of business performance with the previous fiscal year, MarketEnterprise has decided that, beginning with the monthly disclosure for July 2026, it will disclose sales of its core second-hand online business segment with year-on-year comparisons in place of consolidated net sales.
