2. One REIT's Initiatives

One REIT recognizes the importance of ESG (Environmental, Social, Governance) considerations in real estate investment management and promotes sustainability initiatives with the aim of reducing environmental load and realizing a sustainable society, as part of our corporate social responsibility.

In the environmental area, One REIT will continue its efforts for energy saving and effective use of resources and take measures to reduce environmental load. At the same time, One REIT will promote acquisitions of green building certifications granted by external certification institutions in order to demonstrate the quality including environmental consideration of its properties. In addition, the number of properties that have acquired green building certifications among the 28 properties One REIT owns is 24 as of today, accounting for 93.5% of total floor space of the entire portfolio.

<Reference> Overview of the Certification

CASBEE (Comprehensive Assessment System for Built Environment Efficiency) is a method for evaluating and rating buildings based on their environmental performance and a system for comprehensively evaluating environmental consideration, such as energy saving and use of materials with low environmental impact, as well as the quality of buildings including indoor comfort and consideration for landscape.

The Certification was developed with an aim to utilize the results of environmental evaluation of buildings in CASBEE in real estate evaluation, and it rates existing buildings that were completed no less than one year ago based on the four ranks of "Rank S", "Rank A", "Rank B+" and "Rank B".
