The Company has not independently confirmed the actual number of shares beneficially owned or the number of voting rights held by the shareholder. In addition, because the amendment report includes 5,902,500 Class B preferred shares, such shares have been excluded from the number of shares held presented above.

The "total number of voting rights of all shareholders" used for the period before the change is 12,734,013, consisting of 11,660,333 voting rights as of March 17, 2026 (calculated by deducting 770,343 non-voting shares from the total number of issued shares), plus 1,073,680 voting rights attributable to 107,368,000 shares of the Company's common stock issued on March 31, 2026. For the period after the change, the calculation is based on the total of 12,804,439 voting rights recorded in the shareholder register as of June 30, 2026.
