Notice Concerning Changes in Parent Company (Specified Associated Corporation) of the Asset Management Company

Samty Residential Investment Corporation ("Samty Residential") announces that Samty Asset Management Co., Ltd. (the "Asset Management Company"), to which Samty Residential entrusts management of its assets, has changed its parent company (specified associated corporation) (the "Change") as of August 1, 2025, as follows.

1. Background and Reason for the Change

As announced in the press release "Notice Concerning Share Consolidation, Etc. at Parent Company (Specified Associated Corporation) of the Asset Management Company" dated January 10, 2025, it announced that Daiwa Securities Group Inc. ("Daiwa Securities Group") intends to conduct an absorption-type merger, in which Song Bidco G.K. will be the surviving company and Samty Holdings Co., Ltd. ("Samty HD") will be the absorbed company, for the purpose of acquiring equity interest in Song Holdings G.K., the parent company (specified associated corporation) of the Asset Management Company. However, the absorption-type merger was not carried out. Instead, as of today, a share exchange was executed whereby Song Holdings G.K. acquired shares of Samty HD held by Daiwa Securities Group, and in return, Daiwa Securities Group acquired equity interest in Song Bidco G.K. In addition, an absorption-type merger was completed, in which Song Holdings G.K. became the surviving company and Song Bidco G.K. was the absorbed company.

Due to the Change, Song Bidco G.K. has ceased to be the specified related corporation of the Asset Management Company.
