### **Frequently Asked Questions Regarding Changes to the Shareholder Benefits Program**

We have received inquiries from investors regarding the changes to the shareholder benefits program (hereinafter “the Changes”) for the fiscal year ending August 2026 and beyond, as announced in the “Notice Concerning Changes to Shareholder Benefit Program” dated July 3, 2026. In response, and in the spirit of fair disclosure, we are providing the following answers based on the information available at this time.

Details regarding how to use shareholder benefits following these changes will be announced in a notice scheduled to be mailed in late November 2026, as well as on the “Kasumigaseki Capital Premium Benefits Club” website and our company’s website. For the specifics of these changes, please refer to the [“Notice Concerning Changes to Shareholder Benefit Program”](#) dated July 3, 2026.

#### **Questions and Answers**

**Q. Are there any limits on the amount or number of accommodation discount vouchers that can be used per stay?**

A. There are no restrictions.

**Q. Does the fact that these are accommodation discount vouchers mean they cannot be used to cover the full cost of a stay?**

A. You may use the accommodation discount vouchers to cover the full cost of your stay. However, if the value of the vouchers exceeds the cost of your stay, no change will be given, and any unused discount amount cannot be carried over.

**Q. Are the discount vouchers in denominations of 10,000 yen?**

A. We are currently considering offering denominations other than 10,000 yen, but please wait for the official announcement in late November 2026 or later for further details.

**Q. Can I use these vouchers in conjunction with fav points?**

A. Yes, they can be used together.

**Q. What is the validity period for the accommodation discount vouchers?**

A. They are valid for one year, from December 1 of the year of issuance through November 30 of the following year (based on the reservation date, not the date of use). While you can make reservations for dates after the expiration date, please note that if you cancel or change your reservation after the expiration date, the discount will no longer apply.

**Q. Can the accommodation discount vouchers be transferred to others?**

A. We do not plan to restrict use to shareholders only, but we will establish separate rules regarding the method of transfer; please wait for the official announcement in late November 2026 or later for further details.

**Q. Which designated hotels accept the accommodation discount vouchers?**

A. Details are currently under consideration. Please wait for the official announcement in late November 2026 or later.

**Q. Will the designated hotels where the accommodation discount vouchers can be used be limited to specific hotel brands?**

A. Details are currently under consideration. Please wait for the official announcement in late November 2026 or later.

**Q. How do I make a hotel reservation when using the accommodation discount voucher?**

A. Please make your reservation through the hotel's official website. If you do not have an FHG Loyalty Program account, the discount cannot be applied; therefore, we kindly ask that you register as a member yourself via the official website (<https://fav-hotels.com/>).

**Q. Can I use the accommodation discount voucher on booking pages other than the official website?**

A. They can only be used for reservations made on the official website. Additionally, we do not accept reservations using the accommodation discount voucher via phone or other methods.

**Q. Can I use an accommodation discount voucher for a stay I've already booked?**

A. If you complete payment for your stay without using an accommodation discount voucher, you will not be able to use the voucher after payment is complete. You will need to cancel your reservation and make a new one to use the voucher; however, please note that a reservation for the exact same amount may not be available.

**Q. Can I convert wills points carried over from the previous period into wills coins?**

A. You can exchange them for wills coins during this fiscal year's shareholder benefit period.
