**Notice Concerning Approval of Change of Market Segment to Standard Market,
and Withdrawal of Plan to Conform to Continued Listing Standards of Prime Market**

OpenDoor Inc. (the “Company”) announces today that it received approval from the Tokyo Stock Exchange Inc. (hereinafter referred to as “TSE”) to change its market segment to the TSE Standard Market. As a result, the market segment of the Company shares will change from the TSE Prime Market to the TSE Standard Market, effective March 25, 2026.

The Company has been striving to meet the Prime Market Continued Listing Standards in accordance with the "Plan for Compliance with the Standards for Continued Listing in the Prime Market" (hereinafter referred to as the "Compliance Plan") announced on June 18, 2025, but has decided to withdraw the Compliance Plan as of today due to approval to change the market segment to the Standard Market.

The Standard Market is positioned as a market for companies with sufficient liquidity and governance levels for investment in public markets. As for the Company, there will be no change in the Company's ambition for growth, or business strategies and policies, even after the change in market segment. The Company continues to further enhance corporate governance, and strives for sustainable growth and medium- to long-term improvement of corporate value by implementing management that is conscious of stock price.
