# Notice Regarding the Acquisition of Shares in ISM, Inc. (Wholly-owned Subsidiary)

AIS Co., Ltd. ("AIS"), a consolidated subsidiary of our company, acquired 81% of the issued shares of ISM, Inc. (hereinafter "ISM") in July 2025, thereby making it a consolidated subsidiary. We hereby announce that, in respect of the remaining 19.0% of shares, a share transfer agreement was concluded on November 30<sup>th</sup>, 2025, and ISM became a wholly-owned subsidiary as of December 1<sup>st</sup>, 2025. Details are as follows.





### 1. Reason of Acquisition

Our group will make ISM a wholly-owned subsidiary as part of our strategic investment and growth strategy within the medical business, aiming to strengthen the direct sales model and maximise profitability. This full acquisition will establish a framework enabling the integration of the entire business operation process, including sales, customer support, and contract management, under a consistent group-wide policy. This will enable group-led optimisation of sales policies, staffing, pricing structures, KPI design, etc., maximising the value delivered to ISM's regional customer base and clarifying revenue management.

Between 2025 and 2030, our group is pursuing M&A targeting 8 to 10 companies possessing regional networks valued at several hundred million to one billion yen. This will accelerate the transition from the current agency model for the Mighty series (currently approximately 95%) to a direct sales model within the group. This transaction is deemed to be a measure aligned with this policy, contributing to the optimisation of sales channels, the creation of synergies, and the improvement of consolidated profitability. Going forward, the company will continue to strengthen its position as a leading company in the medical field and strive for the sustainable enhancement of corporate value through the promotion of strategic investments and business restructuring.
