**Notice Regarding the Status of the Repurchase of Treasury Stock  
(Repurchase of Treasury Stock Pursuant to the Articles of Incorporation Based on the Provision of

(the “Company”) decided at the Board of Directors meeting held on March 13, 2026, to repurchase treasury stock based on the application of Article 156 of Japan’s Companies Act, pursuant to the rewording under Article 165, Paragraph 3.
