Notice Regarding Establishment of Subsidiary and Change to Specified Subsidiary

At the Board of Directors meeting held on September 26, 2023, Tosoh Corporation (below "the Company") resolved to establish Tosoh Vietnam Polyurethane Co., Ltd (below "the Vietnamese subsidiary") in Vietnam, and subsequently completed its establishment on April 4, 2024. The share capital of the Vietnamese subsidiary is more than 10% of the share capital of the Company, qualifying it as a specified subsidiary of the Company. The Company has determined that, although the Vietnamese subsidiary qualified as a specified subsidiary, the required disclosure under the listing regulations concerning changes in subsidiaries was not made. An apology is extended for this oversight, and although the disclosure is being made retrospectively, the following information is provided regarding the change in subsidiary status.
