2. Position of the Company in the Corporate Group of Any Other Associated Company and Relationship between the Company and Any Other Associated Company, etc.

Dentsu Group Inc. ("Dentsu Group") is any other associated company which has 20.98% of the Company's voting rights, and the Company is an equity-method affiliate of Dentsu Group, after the tender offer for the Company in 2018.

Along with that, Dentsu Group and the Company concluded a capital and business alliance agreement on October 30, 2018. It aims for becoming the biggest digital marketing partners in Japan to lead the development of the industry, and to achieve this, it is intended to maximize the profits of both companies by contributing the resources of both through the transaction and by mutually utilizing them.

To the extent that it contributes to achieve the purpose of the capital and business alliance agreement, taking into account that the Company is a listed company, Dentsu Group will respect its independence and autonomy (including management, business, business relationship and brand

independence and autonomy) to the maximum extent, and the Company recognizes that the independence of its management has been secured.
