## **Notice of Reorganization and Personnel Changes**

AMUSE INC. (the “Company”) hereby announces that at a meeting of the Board of Directors held on March 31, 2026, it passed a resolution with respect to the reorganization and personnel changes. Details are as follows.

### **1. Purpose and Details of the Reorganization (Effective April 1, 2026)**

- The Company will reorganize internal structure with the aim of further strengthening its artist production functions. To enable more agile personnel allocation and human resources development, the Company will consolidate its nine internal companies into two: Production 1, primarily focused on musicians, and Production 2, primarily focused on actors, talents, models, and specialists. In addition, by transferring the rights planning and advertising functions to Production 1, it will establish an integrated production framework that unifies artist management, music rights management, and media and digital promotion.
- The Company will establish a new management-led project organization with the aim of expanding and developing its international business.
