Notice Regarding the Acquisition Additional of Shares in Fileforce Inc.

We are pleased to announce that we have reached a basic agreement with Fileforce Inc. (hereinafter referred to as "Fileforce"), an equity method affiliate, regarding the acquisition of additional shares in Fileforce (including treasury shares held by Fileforce).

1. Purpose of the additional share acquisition

Our company's mid-term management policy is to "transform from a hardware-focused IT infrastructure rental company to a construction ICT specialist company that provides integrated data and information-related services to support work on construction sites ." Based on this policy, we are currently promoting the cloud storage service "Fileforce® For Construction (hereinafter referred to as " FFC ")," which is the core content of the "Site Assist Package (hereinafter referred to as " SAP "), " and it uses Fileforce's platform service "Fileforce® ."

The purpose of this additional share acquisition is to further deepen our collaboration with Fileforce and strengthen our partnership. This will enable us to further enhance the functionality and services of our "FFC" and ultimately expand the possibilities of "SAP."

By increasing the appeal of SAP through this additional share acquisition, we aim to increase the benefits to users and contribute to the sustainable improvement of our group's corporate value.
