2. Reason

The Company's basic policy is to increase shareholder value, and the company considers returning profits to shareholders as one of the most important issues. The Company aims to improve and stabilize the level of dividends by targeting a consolidated dividend on equity (DOE) of 4.3%.

Based on the above policy, the year-end dividend for the fiscal year under review is expected to be ¥51 per share.

As a result, the annual dividends per share is ¥98.
