Notice Concerning Receipt of Dividends from Consolidated Subsidiaries

DKS Co. Ltd. (the Company) will receive dividends from its consolidated subsidiaries. As this corresponds to an event which requires the Company to issue an Extraordinary Report in accordance with the provisions of Article 24-5, Paragraph 4, of the Financial Instruments and Exchange Act, and Article 19, Paragraph 2, Item 12, of the Cabinet Office Order on Disclosure of Corporate Affairs, the Company announces the content thereof as follows.

1. Outline of dividends

2. Impact on financial results

Due to the receipt of said dividends, dividend income of ¥1,924 million will be recorded under non-operating income in the Company's non-consolidated financial statements for the Fiscal Year Ending March 31, 2026.
