Tokyo, Japan (August 1, 2025) – Daiichi Sankyo Company, Limited (hereafter, Daiichi Sankyo) today announced that it has acquired its own shares based on the Articles of Incorporation pursuant to the provisions of Article 165, Paragraph 2 of the Companies Act.
