Notice Regarding Partial Amendment to "Notification of Change of Equity Method Affiliate (Transfer of Shares)"

Otsuka Holdings Co., Ltd. announces a partial amendment to the "Notification of Change of Equity Method Affiliate (Transfer of Shares)" disclosed on July 25, 2025.

Certain details regarding "Outline of the Transferee, Number of Shares to Be Transferred, and Scheduled Transfer Date" have been revised.

The amended sections are underlined below for your reference.

1. Reason for the Amendment

Otsuka Medical Devices Co., Ltd. (the "Company") entered into a share transfer agreement on July 25, 2025, with a total of five counterparties. Among these counterparties, Mr. Jonathan W. Chen has requested to postpone the scheduled closing date due to delays in completing certain procedures required for the share transfer, and to change the contracting party from himself to an entity he owns, in order to expedite the necessary procedures.

The Company remains committed to transferring the shares in accordance with the previously executed share transfer agreement. Hence, the Company has decided to change the transferee and the scheduled closing date as requested by Mr. Chen.
