Announcement of Changes in Representative Directors and Changes in the Executive Structure of Fuji Media Holdings, Inc. and Fuji Television Network, Inc.

Fuji Media Holdings, Inc. (hereinafter referred to as "FMH") has decided to review its management structure and change its representative directors and the executive structure as outlined below at its Board of Directors meeting held today in light of the issues that occurred at our subsidiary, Fuji Television Network, Inc. (hereinafter referred to as "Fuji TV"). This decision aims to regain the trust of all stakeholders. Accordingly, we have decided on changes to the representative directors and the executive structure, as outlined below. These changes are subject to the approval of the director appointment proposal to be presented at the 84th Ordinary General Meeting of Shareholders scheduled for June 2025.

Furthermore, Fuji TV held an extraordinary general meeting of shareholders and a meeting of its Board of Directors today and decided to revise its management structure to restore trust. Fuji TV has transitioned to a new executive structure as of today. However, the incumbent audit & supervisory board members will remain in their positions until the ordinary general meeting of shareholders of Fuji TV scheduled in June, and the incumbent directors appointed from outside Fuji TV will also complete their tenure until the aforementioned meeting.

- 1. Approach to the review of the management structure [comparison between the new structure established in June 2024 and the planned new structure from June 2025 shown in brackets]
 - Reduce the number of directors to strengthen the effectiveness of the Board of Directors and expedite its
 decision making.

[FMH: 17 to 11, Fuji TV: 22 to 10]

• A majority of FMH's Board of Directors will be comprised of independent outside directors to enhance transparency and objectivity and strengthen governance. [FMH: 6 independent outside directors (including 3 newly appointed directors) out of 11 directors, Fuji TV: 6 directors from outside Fuji TV (including 3

newly appointed directors) out of 10 directors]

- Promote diversity within the Board of Directors by setting the ratio of female directors to at least 30%. [FMH: 36.4%, Fuji TV: 30.0% (ratio is 33.3% if including audit & supervisory board members)]
- Considering age diversity within the Board of Directors, newly appoint younger talents in their 50s or below, significantly reducing the average age of directors. [FMH: 71.2 years old to 61.6 years old, Fuji TV: 67.3 years old to 59.5 years old]
- Newly appoint personnel with expertise in areas such as the future of media, internet and streaming businesses, investment ventures, AI and data science, global businesses, international accounting practices, human capital management and HR to drive the development of new business fields and operation process reforms.

[New candidates for Director: FMH: 6, Fuji TV: 6]

- Introduce a full-fledged executive officer system to clarify the separation between supervisory function and executive function of the Board of Directors.
- Through the above measures, both FMH and Fuji TV will implement substantial organizational reforms in their management structures. In Fuji TV, all internally promoted directors and audit & supervisory board members appointed as of January 27 (except for Director Kenji Shimizu who was appointed on the same date) will retire by the conclusion of the ordinary general meeting of shareholders scheduled in June. [FMH: 10 directors to retire, Fuji TV: 20 directors and audit & supervisory board members to retire (the figure for Fuji TV is the aggregate of actual and planned retirees in March and June)].

To establish a structure that allows FMH and Fuji TV to jointly advance reforms, and seek to regain stakeholder trust, enhance group-wide compliance and implement measures to promote sustainable growth.

5. Strengthening of the human rights and compliance systems group-wide

FMH addresses compliance issues and risks that may have a significant impact on group management through mechanisms such as the Committee for Compliance and Risk Management of the Group attended by Group presidents, and the Compliance Officers Meeting attended by Group compliance officers. Furthermore, FMH formulated the Group Human Rights Policy in November 2023, and, based on this policy, has been working to establish internal systems and build a framework for human rights due diligence to respect human rights and conduct business activities in line with the policy.

Despite having these frameworks in place, the recent incident at Fuji TV has underscored the need to address the effectiveness of our systems in terms of awareness, operations and structure. FMH is currently evaluating ways to strengthen the Group's human rights and compliance systems. Furthermore, additional deliberations will be conducted based on the findings of the third-party committee's investigation report expected to be submitted by the end of March.

6. FMH's growth strategy and capital policy

Based on the Medium-Term Group Vision formulated in the fiscal year ended March 31, 2024, FMH has been promoting measures to enhance the growth of the Group, as well as improving return on capital. Although the temporary decline of the Group's consolidated performance and financial condition is inevitable given the incident at Fuji TV, FMH is committed to implementing the aforementioned measures to regain trust and quickly transition to a phase of performance recovery, thereby further advancing the growth strategies of the Group's business.

At the same time, in order to improve capital efficiency and carry out optimal capital allocation, FMH is currently reviewing various aspects including its approach to strategic shareholdings and other assets, growth investments, businesses including new businesses, and shareholders' equity. FMH will announce its goals for improving return on capital and specific measures once they are finalized.
