Notice Regarding Business Alliance with Litpla Inc.

We hereby announce that at the Board of Directors meeting held on August 19, 2025, our company resolved to enter into a business alliance agreement with LitPla Inc.

1. Background and Purpose of the Business Alliance

Our company, together with our parent company, Hulic Co., Ltd. (hereinafter referred to as “Hulic”) and Konami Sports Co., Ltd., has developed an education-focused building called “Kodomo Depart” as a new hub for childcare, providing one-stop services for children. The facility opened in April 2025.

Within “MITAKE LINK PARK” (tentative name), which will house “Kodomo Depart Shibuya” (tentative name) scheduled to open in 2027, we will operate a “Creative Cultural Education Facility” aimed at nurturing children's diverse intellectual curiosity and expanding their individual potential through learning and experiences.

In establishing a digital experience space within this creative cultural education facility, we have entered into a business partnership with Litpla Inc. which operates “Little Planet”, a next-generation theme park where play becomes learning, under the mission of “Creating the Future Through Play.” This partnership will enable us to provide original content that nurtures children's individuality.

2. Overview of the Business Alliance

Our parent company, Hulic Co., Ltd., has been selected by the Shibuya City Government as the developer of the “MITAKE LINK PARK” (tentative name) under the “Urban Regeneration Step-Up Project”, and is currently advancing the development.

As part of this collaboration, our company will operate the “Creative Cultural and Educational Facility” within MITAKE LINK PARK (tentative name), where we will jointly develop original content with Litpla Inc. in the digital experience space of this facility, we will provide digital content that incorporates key elements of intellectual, moral, physical, and creative development, all of which are essential for children.

(1) About “Kodomo Department”

In recent years, alongside the growing number of dual-income households and the government’s expansion of childcare support, investment in children’s “education” has attracted increasing attention. At the same time, reducing the burden on parents—such as securing time for pick-up and drop-off for after-school activities—has become an important social need.

“Kodomo Department” is a new childcare hub designed to address both needs. It will feature our group’s brands, such as our individualized tutoring school “TOMAS” and our subsidiary “Shingakai.” In addition, it will house permanent shops for children’s extracurricular activities, the “Kodomo Department Studio” where children can experience various programs by day and time, as well as a children’s clinic, café, pilates, and postpartum care services. These offerings will serve not only children but also their parents. Through the learning and experiences at “Kodomo Department,” we aim to nurture children’s diverse intellectual curiosity and support each child in creating their own future.

(2) About the “Creative Cultural and Educational Facility”

The Creative Cultural and Educational Facility is designed to provide two types of spaces: one that stimulates children’s learning and thinking activities, and another that fosters creativity, artistic expression, and interaction, with art at its core..
