**Notice Regarding the Status of Acquisition of Treasury Stock

(the “Company”) hereby announces the status of acquisition of treasury stock in accordance with the provisions of Article 156 of the Companies Act as applied by replacing terms pursuant to the provisions of Paragraph 3 of Article 165 of the Companies Act.
