#### Notice of Changes to Organization and Personnel Changes

At the Board of Directors meeting held on March 21, 2025, the Company made decisions on organizational changes and personnel changes, as described below.

#### **Particulars**

- 1. Changes to organization (as of April 1, 2025)
  - (1) In order to provide innovative solutions to address the rapidly changing challenges of the manufacturing industry through unification of technological platforms, the technology-related sections of the Global R&D Division, the Innovation of Engineering Department and the Engineering of Materials Department of the Production Division, and the Sales Engineering Department of the Global Sales Division will be consolidated and reorganized as the Advanced Technology Division. To be established under the Advanced Technology Division will be the Development Planning Department, the Application Engineering Department, the Analytical Research Department, the Materials Development Department, the Engineering Development Department, the Advanced Materials Development Department, and the Process Engineering Development Department.
  - (2) For flexible implementation of strategic investments through centralization of facility management functions, the Facility Department of the Production Division will be integrated into the Plant Project Planning and Development Department of the General Administration Division.
  - (3) In order to further accelerate development and promotion of business strategies, the functions of the Market Strategy Department of the Global Sales Division will be integrated into the Global Business Strategy Department of the Corporate Planning Division.


