5. Organizational Changes (Effective April 1, 2026)

(1) Production Operations

With the aim of enhancing profitability and strengthening product reliability by promoting cost reduction and advanced quality control through the establishment of a production engineering function within Production Operations, as well as realizing the G-TEKT Smart Factory through a cross-functional organization integrating manufacturing sites and production engineering and fostering truly skilled manufacturing personnel, the Company established the Production Engineering Division effective January 1, 2026, and has been developing its organizational structure accordingly.

In addition, effective April 1, the Company will newly establish the Production Engineering Section within the Production Engineering Division and assign personnel thereto in order to further promote its activities.

(2) Sales Operations

With the aim of further strengthening the Company's sales function and expanding strategic order-receiving activities, the Company will integrate the Product Development Division and the Sales Division and reorganize them into the Sales Division.

(3) Corporate Management Operations

With the aim of realizing production transformation and strengthening the Company's earnings structure, the Company will newly establish the Strategy Division.
