**(Update of Previous Disclosure) Announcement Regarding Filing of Final Appeal and Petition for Acceptance of Final Appeal Filed Against a Subsidiary of the Company**

The Company's consolidated subsidiary, IR Japan, Inc. ("the Company's subsidiary") had been subject to a lawsuit ("the Lawsuit") filed by Asia Development Capital Co., Ltd. ("ADC") and Asia Investment Fund Co., Ltd. ("AIF"; ADC and AIF are below collectively referred to as "ADC et al."). On July 18, 2025, the Tokyo District Court handed down a verdict rejecting the claims made by ADC et al. ("the First Instance Judgment"). In response, as disclosed in the Company's September 3, 2025 news release titled "(Update of Previous Disclosure) Announcement Regarding Filing of Appeal Against a Subsidiary of the Company," ADC et al. contested the First Instance Judgment and filed an appeal with the Tokyo High Court. On January 21, 2026, the Tokyo High Court handed down a verdict rejecting the claims made by ADC et al. ("the Appellate Judgment").

On February 16, 2026, the Company's subsidiary received from the Tokyo High Court a written notice of the filing of final appeal, a written notice of petition for acceptance of final appeal, and a petition for final appeal and petition for acceptance of final appeal by ADC et al. ("the Petitions") with regard to the Appellate Judgment. The details are as follows.

1. Court at which the final appeal and petition for acceptance of final appeal were filed and date filed
  - (1) Court: Supreme Court
  - (2) Date of the final appeal and date of petition for acceptance of final appeal: February 6, 2026 (date of receipt of Petitions: February 16, 2026)
2. Circumstances leading to the filing of final appeal and petition for acceptance of final appeal  
As disclosed in the Company's January 21, 2026 news release titled "(Update of Previous Disclosure) Announcement Regarding Favorable Verdict Dismissing Appeal of Decision in Lawsuit Filed Against a Subsidiary of the Company," the Tokyo High Court on that date fully accepted the assertions made by the Company's subsidiary and handed down a verdict rejecting the claims made by ADC et al. However, ADC et al. are contesting the Appellate Judgment and have filed a final appeal and petition for acceptance of final appeal with the Supreme Court ("the Final Appeal").

4. Details of filing of final appeal and petition for acceptance of final appeal

  - Request to reject the original verdict and issue an appropriate verdict
- (3) Reasons for final appeal and petition for acceptance of final appeal  
A statement of reasons for final appeal and a statement of reasons for petition for acceptance of final appeal will be submitted at a later date.

5. Future outlook

As noted in 4. (3) above, a statement of reasons for final appeal and a statement of reasons for petition for acceptance of final appeal have yet to be submitted, but the Company's subsidiary recognizes that the charges were fully considered in the previous trials and that the Appellate Judgment is appropriate, and will therefore respond appropriately to the Final Appeal.

At this time, the Company does not foresee the Final Appeal having any impact on its business performance, and will promptly release further information in the event new information emerges that should be disclosed regarding this matter.
