Notice Regarding Organizational Restructuring, Changes in Executive Responsibilities, and Personnel Transfers

We hereby announce that, at the Board of Directors meeting held on May 15, 2025, our company resolved to implement the following organizational restructuring, changes in executive responsibilities, and personnel transfers.

Details are as follows

1. Organizational Restructuring (Effective June 1, 2025)

To further promote the active participation of female employees, we will establish the "Women's Empowerment Promotion Department."

As approximately 80% of our employees are women, and the percentage of female managers stood at 29.9% as of the end of December 2024, we have actively promoted the advancement of female talent to date. The establishment of this new department goes beyond our previous achievements and aims to build a stronger framework to support further promotion of women and diverse career development. This initiative is intended to accelerate company-wide efforts toward diversity and inclusion.

Furthermore, as gender equality and respect for diversity are gaining increasing importance across society, we view this trend as an opportunity for our own growth. We will continue to promote the development of a workplace environment where all employees can fully demonstrate their abilities.
