Notice Regarding Partial Correction (Revision of Numerical Data) to Financial Results for the Fiscal Year Ended February 20, 2026

ZUIKO CORPORATION (the “Company”) hereby announces that certain corrections have been made to the “Consolidated Financial Results for the Fiscal Year Ended February 20, 2026 (Under Japanese GAAP)” disclosed on April 3, 2026, as described below. In addition, there have been revisions to the numerical data, and the corrected numerical data has also been submitted.

1. Reason for the Correction

After the disclosure of the “Consolidated Financial Results for the Fiscal Year Ended February 20, 2026 (Under Japanese GAAP),” it was found that certain parts of the content contained errors. Accordingly, the Company hereby makes the following corrections.

With regard to the revisions to the numerical data, in the non-consolidated financial results for the fiscal year ended February 20, 2026, it was identified during the audit process that certain expenses should have been reclassified from non-operating expenses to selling, general and administrative expenses. As a result, only operating profit has been revised. There is no impact on the consolidated financial statements arising from this revision.
