Notice Regarding Decision on Matters Concerning Purchase of Treasury Stock

(Purchase of treasury stock pursuant to the provisions of Article 165, Paragraph 2 of the Corporate Law)

RISO KAGAKU CORPORATION (the "Company") announced that its Board of Directors resolved at the meeting held on July 31, 2025 to purchase treasury stock as described below, pursuant to the provisions of Article 156 of the Corporate Law as applied by replacing the relevant terms pursuant to the provisions of Article 165, Paragraph 3 of the same Law.

1. Reason for purchase of treasury stock

The Company will conduct the purchase of treasury stock to carry out capital management that allows the Company to respond quickly to changes in the business environment and to distribute earnings to shareholders.

2. Details of purchase
