## **Announcement for Completion of Acquiring Small Motor Business of Oki Micro Engineering Co., Ltd. and Launch of New Company**

MABUCHI MOTOR CO., LTD. (“Mabuchi”) today announces completion of acquiring the small motor business of Oki Micro Engineering Co., Ltd. (“OKI Micro Engineering”) and launch of a new company named MABUCHI MOTOR MICRO TECH CO., LTD. Mabuchi entered into a share purchase agreement for the acquisition of the small motor business of OKI Micro Engineering and announced on June 7, 2024 the press release titled “Mabuchi Motor to Acquire Small Motor Business of Oki Micro Engineering Co., Ltd.”.

### **1. Purpose of Share Acquisition**

By combining OKI Micro Engineering’s technology and product line-up with Mabuchi’s technology, sales channel and customers base, Mabuchi will generate synergies and establish new business through new product and market development in addition to expansion of existing business.

### **2. Share Acquisition Scheme and Change of Company Name**

#### **(1) Share Purchase Scheme**

OKI Micro Engineering established on May 2025 a new company named Oki ME Co., Ltd. (“OKI ME”) as its subsidiary. OKI Micro Engineering will transfer its business except for a part of business including overseas subsidiary to OKI ME by company split and Mabuchi will acquire all the outstanding shares of OKI ME.

#### **(2) Change of Company Name**

Previous company name : Oki ME Co., Ltd.

New company name : MABUCHI MOTOR MICRO TECH CO., LTD.
