## Notice regarding the completion of the share transfer of IDEC Systems & Controls Corporation

Strengthening core businesses through business restructuring

IDEC Corporation announces that we have transferred all our shares of IDEC Systems & Controls Corporation (IDEC S&C) to Tokyo Gas Engineering Solutions Corporation (TGES) on March 31, 2025.

As part of our structural reforms aimed at sustainable growth and improved profitability, we are currently restructuring our business to create synergies with our core operations. This business transfer is part of that effort.

Since obtaining a specific construction business license in 2012, IDEC S&C has been offering onestop solutions for mega solar power plants, including land acquisition, system design, optimal hardware selection, procurement, construction, various applications, and maintenance. Additionally, they have been providing energy management services to facilitate energy creation and storage.

However, as the renewable energy market expands and the competitive environment becomes more challenging, we have determined that the most effective option for IDEC S&C, a non-core business of ours, to achieve further growth is to join TGES, which has strengths in this sector, and promote the business.

As of today, IDEC S&C has changed its name to S&C Solutions Corporation.
