

## **Notice of Change of Certified Public Accountant**

Tokyo, January 30, 2026 ----- Wacom Co., Ltd. (the “Company”) announced that its Audit Committee, at a meeting held on January 30, 2026, resolved to change the Company’s certified public accountant that performs audit certifications pursuant to Article 193-2, paragraphs 1 and 2 of the Financial Instruments and Exchange Act.

This matter will be decided formally after the approval of the 43rd Ordinary Shareholders’ Meeting scheduled to be held in late June 2026.

The Audit Committee of the Company selected KPMG AZSA LLC as a candidate for the position of accounting auditor, taking into consideration the number of consecutive years of auditing performed by the current accounting auditor and the expectation that the appointment of KPMG AZSA LLC would bring a fresh perspective to the audit. The Audit Committee also considered that KPMG AZSA LLC fully meets the criteria established by the Audit Committee regarding its expertise, independence, quality control system, global audit system, and other relevant factors.

6. Reason and background for the change

The term of the Company's current accounting auditor, PricewaterhouseCoopers Japan LLC, will expire at the end of the 43rd Ordinary Shareholders' Meeting to be held in late June 2026. In view of the number of consecutive years of auditing performed by the current accounting auditor, the Audit Committee of the Company received and reviewed proposals from several auditing firms. As a result, KPMG AZSA LLC is selected as a candidate for the accounting auditor of the Company for the reasons stated in 3 above.
