Supplementary explanation).	Mr. Naofumi Fujie is designated as an independent officer based on the Company's opinion that he satisfies the criteria for independence stipulated in the Guidelines concerning Listed Company Compliance, etc. and the Outside Director Independence Criteria established by the Company (described in 4. Supplementary explanation) and that he will be an outside director who will not have any conflicts of interest with general shareholders.

3	The Company has a trading relationship with Mitsubishi Chemical Group Corporation and Nippon Sanso Holdings Corporation. Mr. Hidefumi Date was an executive officer of these companies in the past, but the Company does not believe that this affects his independence because the amount of the transactions between the Company and Mitsubishi Chemical Group Corporation and Nippon Sanso Holdings Corporation in the immediately preceding business year is less than 1% of the consolidated net sales of the Company and the other two companies, and it does not exceed the standards regarding such amounts in the Company's criteria for the independence of outside directors (described in 4. Supplementary explanation). In addition, Sumitomo Mitsui Trust Bank, Limited is a major lender of the Company. Mr. Hidefumi Date is an outside director of the bank (and a member of its audit and supervisory committee), but this is not of sufficient significance to affect his independence as an outside director of the Company.	Mr. Hidefumi Date is designated as an independent officer based on the Company's opinion that he satisfies the criteria for independence stipulated in the Guidelines concerning Listed Company Compliance, etc. and the Outside Director Independence Criteria established by the Company (described in 4. Supplementary explanation) and that he will be an outside director who will not have any conflicts of interest with general shareholders.
