(2) Reason of change

Heather Montgomery has served as a visiting researcher at research institutes affiliated with governments and financial institutions, and as an expert on macroeconomics and international finance, she has demonstrated her expertise in a wide range of fields in the Japanese and US financial and fiscal sectors. She became an associate professor at the College of Liberal Arts at International Christian University in 2007, and currently teaches as a professor in the Department of Economics and Business at the same university. She is actively engaged in collaborative research not only on macroeconomics but also on corporate behavior and governance in financial institutions and other organizations.

Having been involved in education for many years, she also has experience in corporate management, making her well-suited to serve as an Outside Director of the Company. The Company has nominated her as a candidate for Outside Director, expecting that she will provide supervision and advice on the Company's business based on her extensive knowledge and experience, and that she will contribute to promoting the advancement of women and accelerating initiatives by leveraging her global experience.
