### FY2025 1Q - Status Compared to Initial Forecast


- Each progress condition is increasing more than planned.


Quarterly Net Sales

Shonan Seminar Co., Ltd. has been included in the scope of consolidation since FY2021 2Q. Mori JUKU schools run by Shonan Seminar Co., Ltd. were transferred to SPRIX in FY2024 1Q.


### FY2025 1Q - Net Sales Variance Analysis (Year on Year)

- In the Mori JUKU segment, net sales increased due to healthy trends in the number of students.
- In the Shonan Seminar segment, net sales increased due to an increase in the unit price per student following an expansion of content for elementary school students at Shonan Seminar.
- In the Kawaijuku Manavis segment, the number of students in all grades increased and net sales increased owing to bolstered enforcement of KPI management and operations.
- Net sales in other segments increased, mainly due to the net sales of the Sora JUKU and Tokyo Dance Village businesses.




### FY2025 1Q - Quarterly Operating Profit

 Operating profit increased owing to the increase in net sales at both SPRIX and Shonan Seminar Co., Ltd., as well as a reduction in depreciation following the relocation of the Shonan Seminar Co., Ltd. headquarters, the impact from the end of the partial amortization of customer-related assets that began when Shonan Seminar Co., Ltd. joined the Group in FY2020, and expenses being recorded as planned.





- For Kawaijuku Manavis, the number of students in all grades steadily increased.


