### \* Proper use of earnings forecasts, and other special matters

The above forward-looking statements are prepared based on judgment and assumption from information currently available to the Company. These statements do not purport that the Company pledges to realize such statements. Actual business results may differ from the forecast figures due to various factors such as uncertainties of the information, future economic conditions, stock prices and exchange rates trends.

## 1. Overview of Business Results, etc.

### (1) Overview of Business Results for the Nine Months Ended December 31, 2025

Consolidated revenue for the first three quarters was ¥830.6 billion (up 5.5% YoY), owing mainly to higher client production volume.

Operating profit was ¥52.5 billion (up 11.5% YoY) and third quarter profit attributable to owners of the parent was ¥43.8 billion (up 36.0% YoY), despite price revisions and rising salary costs, owing mainly to cost improvement and higher sales volume.

Results by segment were as follows.

#### (i) Japan

Revenue was ¥350.8 billion (up 7.8% YoY), owing mainly to higher client production volume.

Segment profit was ¥11.3 billion (up 17.7% YoY), chiefly due to cost improvements and higher sales volume.

#### (ii) Americas

Revenue was ¥312.3 billion (up 5.1% YoY), owing mainly to higher client production volume.

Segment profit was ¥22.4 billion (up 8.3% YoY), despite a negative impact from US tariffs, chiefly due to cost improvements and higher sales volume.

#### (iii) Europe and Africa

Revenue was ¥25.0 billion (up 2.7% YoY), owing mainly to the impact of yen depreciation.

Segment profit was ¥1.9 billion (down 8.2% YoY), chiefly due to higher fixed costs.

#### (iv) China

Revenue was ¥68.3 billion (down 8.4% YoY), owing mainly to lower client production volume.

Segment profit was ¥2.1 billion (up 107.9% YoY), despite lower sales volume, chiefly due to fixed cost reductions.

#### (v) Asia

Revenue was ¥108.9 billion (up 6.6% YoY), owing mainly to higher client production volume.

Segment profit was ¥10.3 billion (up 0.8% YoY), chiefly due to higher sales volume and cost improvements.

#### (vi) India

Revenue was ¥37.3 billion (up 19.9% YoY), owing mainly to higher client production volume.

Segment profit was ¥4.2 billion (up 37.8% YoY), chiefly due to higher sales volume and cost improvements.

### (2) Overview of financial position at end of third quarter

Assets at the end of the third quarter in consolidated accounts were ¥1,012.8 billion, up ¥99.8 billion from the end of the previous fiscal year, owing mainly to an increase in cash and cash equivalents.

Liabilities were ¥366.6 billion, up ¥41.9 billion from the end of the previous fiscal year, owing mainly to an increase in bonds and borrowings.

Equity was ¥646.2 billion, up ¥57.8 billion from the end of the previous fiscal year, mainly due to an increase in Retained earnings.

### (3) Forecasts for Consolidated Financial Results and Other Forward-looking Information

The Company forecasts for the full fiscal year are changed from the forecasts announced on October 31, 2025. The revised forecasts are for revenue of ¥1,140.0 billion, operating profit of ¥70.0 billion, profit before tax of ¥78.0 billion, and profit attributable to owners of the parent of ¥53.0 billion. For details, please see the “Notice of Revisions to the Full Fiscal Year Forecasts of Financial Earnings for the Fiscal Year Ending March 31, 2026” announced today.

The forecasts are premised on exchange rate assumptions of ¥150 to US\$1 for the fourth quarter and ¥149 to US\$1 for the full fiscal year.

(Notes on Business Combinations)

At a meeting of the Board of Directors held on August 8, 2025, the Company resolved to acquire the common shares and stock acquisition rights of Ashimori Industry Co., Ltd. ("Ashimori Industry") through a tender offer under the Financial Instruments and Exchange Act (the "Tender Offer"). The Tender Offer commenced on August 12, 2025 and was completed on October 30, 2025.

As a result of the Tender Offer, Ashimori Industry became a consolidated subsidiary of the Company on November 6, 2025.

In addition, at an extraordinary general meeting of shareholders held on January 27, 2026, Ashimori Industry resolved to implement a share consolidation with an effective date of March 1, 2026.

(1) Details of Business Combination

Acquired company: Ashimori Industry, 14 subsidiaries, and one affiliated company

Businesses of acquired company: Automobile safety parts, functional products

Primary reason for the business combination

The Company acquired Ashimori Industry as a consolidated subsidiary to accelerate growth in the Company's safety systems business through closer cooperation with Ashimori Industry, and to generate synergies in Ashimori Industry's functional products business.

Date of business combination: November 6, 2025

Legal form of business combination: Acquisition of shares through tender offer

Proportion of voting rights acquired: 61.4%

As a result of remeasuring the equity interests in Ashimori Industry previously held by the Company at their fair value as of the acquisition date, a loss of ¥1,071 million was recognized. This loss is recorded under "Other expenses" in the condensed quarterly consolidated statement of profit or loss.

In addition, acquisition-related costs of ¥236 million, including advisory fees related to the business combination, are mainly recorded under "Selling, general and administrative expenses."

As the purchase price allocation has not been finalized, the fair values of the assets and liabilities are provisional amounts recognized as of the acquisition date and may be adjusted during the measurement period (one year from the acquisition date).

The contractual amounts receivable of the acquired trade and other receivables amounted to ¥14,515 million, and the estimated contractual cash flows not expected to be collected amounted to ¥19 million.

Non-controlling interests are measured based on the ownership interests of non-controlling shareholders in the fair value of the identifiable assets and liabilities of the acquiree group.

In addition, as the acquired assets and assumed liabilities were measured at fair value in connection with the business combination and compared with the acquisition consideration, any resulting gain on bargain purchase is recorded under Other income.
