Notice Regarding New Selection as a Constituent Stock of the “JPX-Nikkei Mid and Small Cap Index” for Fiscal Year 2026

FP Partner Inc. (Headquarters: Taito-ku, Tokyo; Representative Director and President: Tsutomu Kuroki; Securities Code: 7388), which operates the free financial planning consultation service “Money Doctor,” is pleased to announce that it has been newly selected as a constituent stock of the “JPX-Nikkei Mid and Small Cap Index” for fiscal year 2026 (August 31, 2026, to August 30, 2027).

1. About the JPX-Nikkei Mid and Small Cap Index

The JPX-Nikkei Mid and Small Cap Index is a stock index composed of companies that efficiently utilize capital and conduct management with a focus on investors, applying the concept introduced in the JPX-Nikkei Index 400—which selects “companies with high investment appeal for investors”—to small- and mid-cap stocks. It is jointly calculated by JPX Market Innovation & Research, Inc., and Nikkei Inc.

2. Selection of Constituent Stocks

Constituent stocks are selected from common shares listed primarily on the Tokyo Stock Exchange’s Prime Market, Standard Market, and Growth Market. After screening based on market capitalization and market liquidity indicators, the selection is made using a scoring system that combines quantitative indicators (three-year average profit margin (ROE), three-year cumulative operating profit), as well as qualitative factors (appointment of a majority of independent Outside Directors, appointment of female executives, implementation of English-language disclosures, etc.). The top 200 stocks are selected based on these criteria.

We will continue to strive to further enhance our corporate value in order to meet the expectations of our shareholders and investors.
