Notice Concerning Determination of Matters Pertaining to Repurchase of Own Shares

(Repurchase of own shares according to the Articles of Incorporation pursuant to

(the “Company”) hereby announces that the Company has resolved at the meeting of the Board of Directors held on April 2, 2026 the matters pertaining to the repurchase of its own shares pursuant to Article 156 of the Companies Act, as modified and applied in accordance with Article 165, Paragraph 3 of the Companies Act, as described below.

1. Reason for repurchase of own shares

The Company will repurchase its own shares for the purpose of implementing a flexible capital policy in response to changes in the business environment and returning profits to shareholders.
