Avex Music Group Songwriter, Kamal Wilson Wins “Best R&B Song” at the 68th Grammy Awards

Kamal received the award for his contribution to Kehlani’s song “Folded.”



Kamal Wilson is a songwriter and producer from Orange County, California. Since writing his first song at the age of 11, he has been active across multiple genres, including R&B, hip-hop, and pop.

The award-winning song “Folded” was created through Kamal’s ongoing creative partnership with Kehlani. The track reached No. 6 on the Billboard Hot 100, topped both the U.S. Rhythmic and Urban radio charts, and ranked among the top songs on Apple Music, establishing itself as a global hit. At this year’s Grammy Awards, the song also earned Best R&B Performance, awarded to Kehlani.

This recognition affirms that Kamal’s exceptional songwriting talent and collaborative work with artists have been recognized on one of the music’s most prestigious stages. AMGL holds the publishing rights to the song, and this achievement represents a symbolic milestone reflecting the successful strengthening of Avex’s North American creative infrastructure under its global strategy, “avex vision 2027.” In particular, the consolidation and integration of leading U.S. artist management company S10 Entertainment & Media LLC as a subsidiary in March 2025 significantly enhanced Avex Music Group’s presence in the North American market.
