Notice regarding filing of arbitration claim against our Thai consolidated subsidiary

Sanko Gosei (Thailand) Co., Ltd. (hereinafter "STL"), a consolidated subsidiary of the Company in Thailand, has been sued in a Thai arbitration court (hereinafter "the Lawsuit"). The lawsuit has been delivered to STL by post on February 16, 2026 (local time). We hereby announce the details as follows.

#### 1. Cause of Lawsuit and Background to the Case

In November 2021, STL received a notice from Siam Aisin stating that vehicles using the automotive brake parts manufactured and delivered by STL to Siam Aisin for the period from June 2018 to November 2018 were subject to market recall and that the company wanted to discuss how to handle the related costs. Since then, the two parties have engaged in discussions for the issue of liability. Siam Aisin, however, has filed a petition with the Thai Arbitration Commission seeking payment of substantially all of the costs of the vehicle recall, alleging that STL is entirely at fault.

In this lawsuit, the plaintiff is seeking damages from STL. According to the complaint, the plaintiff is seeking 984,568,198.17 Thai baht in damages. This amount is based solely on the plaintiff's assertions, and our Group does not acknowledge its validity.

We will sincerely and appropriately explain our position and respond fairly to the proceedings in arbitration, while simultaneously finding the possibility of the settlement for the compensation amount through outside of arbitration.
