## **Notice Regarding Reorganization and Personnel Transfers**

At the meeting of the Board of Directors held on December 9, 2025, Pigeon Corporation ("the Company") passed a resolution for a reorganization and personnel transfers as follows, to be implemented on December 16, 2025.

## 1. Reasons for the Change and Personnel Transfers

Pigeon is drafting the 9th Medium-Term Business Plan, which will begin in 2026, and intends to publish the Plan in February 2026. To prepare for implementation of this Medium-Term Business Plan, Pigeon is optimizing its executive organization and reassigning personnel to achieve still greater prominence in the global market. The purposes of these changes, some of the most significant since our foundation, are threefold: 1) to promote our businesses in each market in ways that will dramatically expand sales and market share; 2) to boost profitability by improving management efficiency; and 3) to reinforce Group governance.

## 2. Change in Executive Organization

Pigeon is scrapping the Business Strategy Division and Accounting & Finance Division of Global Head Office and appointing officers to the following senior ("CxO") positions, reporting to the CEO: Chief Product & Supply Chain Officer (CPO/CSCO); Chief Strategy Officer (CSO); Chief Financial Officer (CFO); Chief Human Resources Officer (CHRO); and Chief Branding Officer (CBO). These "CxOs" will take charge of their respective functions globally.

With this reorganization, Pigeon aims to accomplish three objectives: 1) streamlining, enhancement and resource optimization of functions across all Divisions; 2) specialization by function and achieving faster decision-making; and 3) improving governance by bringing clarity to responsibility and reporting frameworks.

## 3. Transfer of Managing Officers

(1) Establishment of a new position: Group Executive Officer

The leaders of the three Divisions ("business officers") and four CxOs according to function ("management officers") are newly appointed as Group Executive Officers. The Group Executive Officers are tasked with advancing growth of operations and strengthening Pigeon's management base.

(2) Introduction of "job-based" personnel and evaluation systems



The relationships between the roles and responsibilities of each Group Executive Officer position and their compensation will be clarified and appropriate procedures will be established for personnel and evaluation processes. In this way a framework will be established for assignment and placement of personnel as Group Executive Officers at the global level.
